### **Q1 SUMMARY**


During the first quarter of 2015, CERF supported life-saving humanitarian aid operations in 17 countries with allocations totalling US\$103.4 million.

The Emergency Relief Coordinator (ERC) allocated \$17.6 million from CERF's Rapid-Response Window for emergencies in five countries this quarter. These grants included \$10.9 million in support of thousands of families displaced by major floods in Malawi and Mozambique.

The ERC also approved some \$100 million for aid operations in Syria and poorly funded crises in 11 other countries as part of CERF's first round of Underfunded-Emergencies Window allocations. This is the first of two rounds of CERF funding in 2015 to boost aid operations in countries where humanitarian needs are high but financial support is low.

At the end of the quarter, the ERC approved \$28 million for life-saving relief work for people fleeing violence in Nigeria. These allocations will be allocated in the second quarter and are not included in the totals presented in this update.



### Q1 RAPID RESPONSE ALLOCATIONS

The ERC allocated \$17.6 million through CERF's Rapid Response Window in the first quarter of 2015. These funds supported aid agencies responding to humanitarian crises in five countries.

### MALAWI AND MOZAMBIQUE

In January 2015, heavy rains and floods displaced 230,000 people in Malawi, and 50,000 people in Mozambique. With thousands of families in need of urgent assistance, the ERC approved \$10.9 million from CERF to support the emergency response.

"The Humanitarian Country Teams in both countries requested CERF funding to kick-start emergency relief efforts. CERF has been part of the collective effort to provide critical, life-saving assistance for those affected by the floods in Malawi and Mozambique," said Mr. Ignacio Leon-Garcia, Head of the United Nations Office for the Coordination of Humanitarian Affairs (OCHA) Regional Office for Southern Africa.

CERF allocated \$7 million for Malawi, where displaced families fled with what little they could carry. Many had found shelter in makeshift structures, schools, churches and other public buildings while thousands were forced to sleep out in the open.

"The funding comes at a critical time. We are working hard with a range of partners to scale up our support to the Government-led response to save lives and bring food, medicine and other vital supplies to flood-affected areas," said Ms. Mia Seppo, UN Resident Coordinator in Malawi, when the allocation was announced.

In neighbouring Mozambique, CERF provided \$3.9 million for relief operations for 50,000 people housed in temporary in accommodation facilities in hardest hit Zambézia province.

With these funds, humanitarian partners in Malawi and Mozambique provided urgent aid including food, shelter, clean water and sanitation services and seeds and tools so for affected farming families.


#### **VANUATU**

Tropical Cyclone Pam swept through the archipelago of Vanuatu in the Pacific on 13 March 2015, wiping out homes, infrastructure and crops.

Aid agencies estimated that some 75,000 people were in need of shelter and 110,000 people lacked access to safe drinking water. More than half the country's population was affected by the storm.

In response, the ERC immediately approved \$5 million from CERF for the provision of emergency life-saving assistance for thousands of people. Aid included the provision of clean water, food, shelter and health care and education and protection support for children. Funds were also used to support telecom and logistics services to help enable coordination of the emergency response.

## **Q1 UNDERFUNDED EMERGENCIES**

In January 2015, the ERC approved some \$100 from CERF's first round of Underfunded-Emergencies Window to boost life-saving work in Syria and 11 other countries.

The ERC allocates funding through CERF's Underfunded-Emergencies Window twice a year to provide a temporary lifeline for people caught in crises where current donor contributions fall short but needs are extreme and major assistance is required.


Some \$77.5 million has been allocated to countries affected by the Syria crisis. The highest single allocation will go to Syria (\$30 million), and the remainder will go to humanitarian agencies in Egypt (\$3.5 million), Iraq (\$8 million), Jordan (\$9 million), Lebanon (\$18 million) and Turkey (\$9 million).

"Despite critical funding gaps, humanitarian workers remain committed to helping every vulnerable Syrian they can. This allocation from CERF will help ensure that they can continue their life-saving work," said Ms. Amos. In less than four years, the number of people in need of humanitarian assistance in Syria has gone from one million to over 12 million. Many more have fled to find refuge across the border.

Another \$14 million will support aid operations in three countries in the Great Lakes Region in Africa, where the long running conflict in the Democratic Republic of the Congo (DRC) continues to have disastrous effects. Aid agencies in DRC (\$9 million) and neighbouring Burundi (\$2.5 million) and Rwanda (\$2.5 million) will receive funds to provide urgent assistance for people displaced by violence and the vulnerable communities that host them.

Additionally, humanitarian partners in Colombia (\$3 million), Djibouti (\$3 million) and the Democratic People's Republic of Korea (\$2 million) will receive support to sustain long-standing, but critically underfunded humanitarian operations, including the delivery of food and basic health services.

"This underfunded emergencies allocation of \$100 million will help millions of people who are caught in crises where the scale of needs has outpaced contributions," said Ms. Amos.



## Q1 CONTRIBUTIONS OVERVIEW

During the first quarter (Q1) of 2015, CERF received \$103.6 million in contributions. Of that amount, 98.7 per cent (\$102.3 million) is for 2015. The remaining 1.3 per cent covers outstanding commitments for 2014.

These donations brought total contributions for 2015, including funds received for 2015 in late 2014, to \$106.7 million, or 23.7 per cent of CERF's \$450 million annual funding target. This is 25.4 per cent of the \$419.3 million pledged to-date for 2015.

CERF is working with key donors to time their contributions to try to mitigate potential losses related to currency fluctuations. A drop in the value of currencies of most major contributors to CERF against the US dollar over the past months is likely to result in a realized loss of the actual dollar contribution in 2015 versus the amount pledged in December 2014.

## **Q1 CERF SECRETARIAT UPDATES**

#### MEMBER STATES BRIEFING

The first CERF Member States briefing for 2015 took place in New York on 25 March. The Emergency Relief Coordinator (ERC), Valerie Amos, briefed Member States on the use and impact of CERF in 2014 and 2015 and explained the main findings of two scoping studies on a reformed CERF (more in next column). This was the Ms. Amos' last briefing on CERF.

#### STUDIES ON A REFORMED CERF

In March 2015, CERF published two scoping studies to look at CERF's role in the changing humanitarian landscape and to ensure that funding entrusted to CERF effectively and efficiently serves those people most affected by crises.

The studies focussed on two issues: whether expanding CERF's annual funding target beyond \$450 million would better position CERF to respond to growing global humanitarian needs; and the viability of using UN assessed contributions to fully or partially fund CERF.

Those interviewed – including donor and recipient agency representatives and NGOs – stressed CERF's importance in ensuring an effective global humanitarian response and commended the fund for being:

- focused on its objectives;
- fast, flexible and well-managed;
- well-supported by donors; and
- crucial for ensuring an immediate response to emergencies of all sizes.
