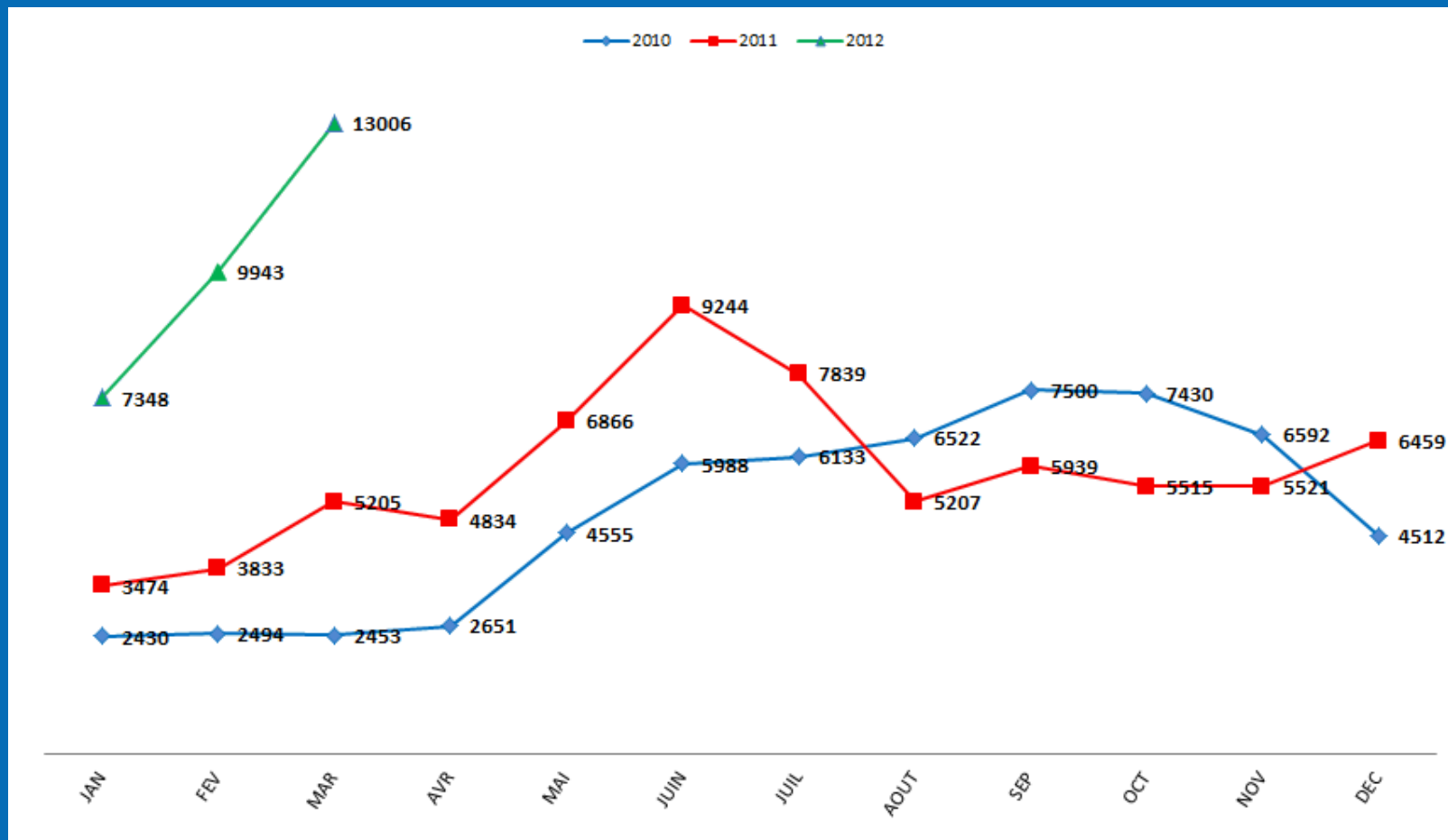


Humanitarian situation

Food Security/Nutrition

- 3.6 million people in food insecurity in the Sahel belt among which 1.5 million severely hit and need immediate assistance
- 127,000 children affected by severe acute malnutrition in the Sahel belt
- 13,000 admissions in CNTs in March 2012 compared to 5,200 in March 2011

Humanitarian situation

Epidemics (as of April 2012)

- Meningitis: 3,190 people affected including 145 deaths (4.5% lethality rate). 6 health districts in epidemic; 4 on alert. 1.17 M dozes mobilized
- Poliomyelitis: 3 wild poliovirus notified. 4 rounds of vaccination organized since January 2012
- Cholera: No case registered in 2012.
17,285 cases in 2011 (459 deaths)

Humanitarian situation

Population Movements

- Nigeria: over 1,000 people arrived in Ngouboua in February 2012; Assistance is ongoing
- Libya: over 90,000 Chadians and TCNs returned to/transited through Chad

IDPs

- 125,000 IDPs on site and 56,000 returnees (excluding spontaneous return)

Refugees

- 274,640 Sudanese and 67,863 CAR

CERF Allocations

2011

- RR: US \$14,513,880

Epidemics, Humanitarian Access (UNHAS)

- UFE: US \$ 8,039,204

Nutrition, Food security

2012

- RR: US \$2,979,447

Food Security and Malnutrition crisis

- UFE: US \$7,931,609

60% Early Recovery, 40% Sahel crisis

Challenges

- Quality of information along reporting cycle
- Difficulty to define a life-saving criteria
- Disbursement delay between UN and NGOs
- Difficulty to monitor implementation
- NGOs are not directly eligible for funding
- Agencies tend to privilege their own programmes

Way forward

- Improved donor and NGO participation for greater transparency
- Reinforce the qualitative reporting system
- Greater awareness on the CERF process among the humanitarian community in Chad.
- Application of IASC gender marker framework
